- 1. Remain at the scene of the accident. Failure to do so can result in serious criminal charges. See our website article "How A Personal Injury Claim Can Turn into Criminal Charges."
- 2. Check yourself and others involved for injuries including pedestrians and provide help to the best of your ability.
- 3. Call 911 for emergency medical help.
- 4. Call the police and make an accident report regardless of how minor the accident is.
- 5. Take pictures of the scene of the accident, if possible, if not, draw a rough sketch of the accident and write down details of the accident.
- 6. Exchange information, such as names, contact numbers, email addresses, mailing addresses, and insurance information with other drivers and witnesses.
- 7. Call your insurance company to provide them with information and ask about time limits for filing a claim and what the process is.
- 8. Get a copy of the police report and keep all pertinent documents.
- 9. Follow through with all recommended medical treatments.

## Mistakes that can Jeopardize Your Case for Injury Compensation from an Automobile Accident

If you have been involved in a car accident you know that adrenalin levels can be high and disorienting. However, understanding what to do and what not to do after an accident can go a long way to ensuring that you do not jeopardize your compensation claim.

A single statement, action, or inaction can weaken a compensation claim. Every case is unique and without advice from an automobile accident attorney in NC, you may say or do something that keeps you from collecting the damages you deserve. Damages that can include payment of your medical expenses, future medical expenses, lost wages, pain and suffering and punitive damages. The most common mistakes to avoid after an automobile accident include the following:

- 1. Try to avoid detailed conversations with any of the other drivers involved. Avoid telling others involved that you are ok, when you think there is a chance you may be injured.
- 2. If possible, and if it is safe, stay seated in your car until first responders arrive.
- 3. Do not admit guilt or express remorse to anyone.
- 4. Do not give the other driver's insurance company more information than the law requires. You must give your name, address, and phone number.
- 5. Do not delay medical treatment, if you are hurt, seek medical attention right away and follow the treatment plan including not returning to work before you are released to do so by your treating physician.

- 6. Do not sign anything from the other driver's insurance company without having an attorney review it on your behalf.
- 7. Do not put off speaking with an attorney about your case.
- 8. Avoid downplaying the possible nature of your injuries. The adrenaline of being in an accident can sometimes mask your pian and injuries. Also, we are all busy and have things to do other then spending hours at a hospital, so your initial reaction may be to think that you are ok and that you don't need medical attention. Place your own health and well-being as your number one priority. If you believe you may have been injured in any way, or you are feeling pain you did not have before the accident, ask for medical attention at the scene.

You may have a personal injury case and be entitled to compensation in North Carolina if your car accident attorney in North Carolina can prove there was a legal duty to use care; another driver violated that duty, and the violation directly caused the accident and your injury.
